PRESIDENT'S MESSAGE

As the spring flowers start to bloom, I'm excited about the potential blooming of our neighborhood's business district. You might recall one of my prior messages concerned this topic and I'd like to give you an update. A group of neighbors has been holding brainstorming sessions and meeting with financial institutions in an effort to understand and explore the possibilities currently facing North Avondale. We have several opportunities right now, and my hope is that exciting things happen to improve our neighborhood.

A recent development at DeSales Corner in Walnut Hills has many of us excited and dreaming about what could happen in our neighborhood. If one Cincinnati neighborhood can come together with the city, banks and developers to create a new neighborhood destination – filled with retail and living spaces – why can't North Avondale? The answer is we can, and the effort to explore such a development has begun. We're just in the exploration phase, however, we're encouraged by what we've learned so far.

Other potential business locations are just waiting for the right person to make a commitment to North Avondale. The Talbert House is now for lease and would make a great location for a business of some sort. The bible college at the corner of Reading and Dana is still for sale, and this is a prime location for a business as well. Our hope is that as we explore neighborhood development, we'll make the right connections with an appropriate business that's looking for a location within the city.

As you might recall, the National Guard armory on Reading Road will, in several years, be turned over to the city after a new facility is built. This means we have the opportunity to propose a new use for the property, with the hope that the city will turn the property over to the neighborhood for redevelopment. Some ideas that have been proposed for the armory property include new housing, use as an arts/sound studio/exercise center or new retail space. Due to the timeframe on the actual transfer to the state, this project is years in the future, however, it's worth investing time and effort now to ensure that we all benefit when the National Guard vacates the property.

In order to make these dreams reality, we can use the ideas, expertise and time of interested North Avondale residents. If you have experience with development, know someone with the kind of knowledge we need, know of a business looking for a new location or are willing to invest your time helping these efforts, please call the NANA office! If we all work together, we can make North Avondale an even better place to live, and we just might see our revitalized business district celebrated in the news.

NEW PROPOSED CITY ZONING CODE WILL AFFECT EVERYONE

A map delineating the proposed new zoning designation for every property in North Avondale will be on display at the April 8th monthly NANA meeting. Information about what will be permitted in the new zoning classifications will also be available. Knowledgeable NANA Board members will give an explanation of the proposed changes and their implication and/or impact. Among the proposed changes are:

- Some R1-A (now called SF-20) zoned properties that require

20,000 square foot lots for a single family dwelling have been changed to SF-10, single family dwellings on 10,000 square foot lots;

- The Transitional (T) zoning classification which requires a public hearing and possible conditions for specific uses has been eliminated and the properties re-classified. In North Avondale these sensitive T zones are at the following locations:
 1. Avondale Avenue - rear part of Gershuny property
 2. Paddock Road - next to Antonio's Pizza
 3. Marion Avenue - some properties in dead-end section
 4. Clinton Springs - west of Wess Park Drive at entrance to Schuman property backing up to west side of Wess Park Drive
 5. South Fred Shuttlesworth Circle (South Crescent) - some properties in middle of street
 6. Kessler Ave. - area off West Mitchell
- Wireless communication towers are permitted in ALL residential zones as a "Conditional Use"
- It is unclear whether "Conditional" uses of properties require a public hearing as current zoning code requires.

These are some of the proposed changes that NANA Board members have identified so far as the new zoning code text is being reviewed. The proposed new zoning code will be presented to the Cincinnati Planning Commission and City Council for approval in the next 2 to 3 months. The plan is to have final approval by City Council before it goes on its summer schedule, meeting once a month in July and August.

Among the stated goals of this new zoning code are that it "preserve the character and quality of residential neighborhoods" and that it "promote the economic stability of existing land uses and protect them from intrusions by inharmonious or harmful land uses." It is important that all concerned citizens review the proposed zoning to determine if it meets these goals as to their property, properties near them and as to the North Avondale neighborhood. Zoning is everything for North Avondale to continue as a successful stable and diverse neighborhood. NANA needs to know how you feel about the proposed new zoning code so that it can properly represent your interests at City Hall hearings.

YARD & REGULAR WASTE COLLECTION INFO

Yard Waste Collection will begin again after the winter hiatus (mid-January through March) during the week of **April 7, 2003**.

All types of yard waste are accepted including grass clippings, leaves, branches and brush.

Guidelines:

- Place yard waste at your curb by 6 a.m. on your regular trash collection day beside your household trash and green recycling bin.
- Place yard waste in biodegradable brown paper yard waste bags, trash cans CLEARLY MARKED "YARD WASTE" or 95-gallon carts.
- Purchase yard waste bags at area grocery stores and hardware stores. To purchase carts, call Premiere Waste at 281-0882 (\$49.00 to \$89.00 with free delivery) To view the carts online go to www.cincicarts.com
- Yard waste in plastic bags **will not** be collected.
- Branches and brush should be tied into bundles no larger than 4'x2' and individual tree limbs should be no larger than 6" in diameter.

Please compost yard waste at home whenever possible. Grass clippings can be left on the lawn instead of bagged. Plastic bags are not accepted at composting facilities.

Waste Collection

Remember, place cans at the curb by 6 a. m. on your regular trash collection day and **no earlier than 5 p.m.** on the preceding day. All cans should be no larger than 30 gallons and weigh no more than 60 lbs. They should have two handles and tight-fitting lids. Plastic garbage bags are acceptable. Please do not overstuff. Please do not use cardboard boxes to hold trash.

Holidays - When a holiday falls on a weekday, all collections for that day will be collected on the following day and all collections for the remainder of the week are delayed for one day. Holidays that effect trash collection are: New Year's Day (January 1), Martin Luther King Day (third Monday in January), President's Day, Memorial Day (last Monday in May), Independence Day (July 4), Labor Day (first Monday in September), Veteran's Day, Thanksgiving Day (fourth Thursday in November), Christmas Day (December 25).

Household solid waste may include:

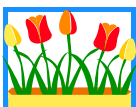
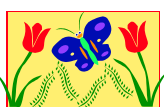
- Up to 3 bulk items, such as furniture and mattresses
- Carpet, bundled and tied in 4'x2' rolls.
- Up to 4 tires
- Wood, bundled no more than 4' long and 10 lbs maximum

Heavy metal items such as discarded refrigerators and metal furniture are collected as an additional service. An appointment is required for pickup of these items. Please call 591-6000 to schedule pick up.

Dead Animal Removal

The Department removes dead animals from the right-of-way. In addition, we are glad to remove deceased pets from the homes of our residents. Dead animals are collected 24 hours a day with pick up normally within 2 hours of the request. If we can help you please call 591-6000.

APRIL AMNESTY FOR JUNK VEHICLES

Spearheaded by Council Member Pat DeWine City Council passed a Junk Vehicle Ordinance on March 5, 2003 which declares that storage of junk vehicles in public view on **residential and commercial private property to be a public nuisance.** The law provides for "the immediate removal of any illegally stored, unlicensed, inoperable or junk vehicle not abated within seven days of receiving a notice of a violation." The ordinance empowers the Departments of Health, Buildings & Inspections, Public Services and the Police to inspect and to enforce this law. The Junk Vehicle Ordinance is the latest in a series of measures by City Council to toughen laws governing "quality of life" offenses such as litter, graffiti, signs on utility poles and aggressive panhandling. "These types of things together lead to a climate that creates crime, so it's important not to tolerate disorder of any kind," DeWine stated.

To encourage people to get rid of inoperable vehicles without facing a citation or fine, City Council passed a motion on March 19 declaring an April Amnesty. During the month of April the City will remove junk vehicles FREE. After May 5 owners of junk vehicles will be cited and if not removed in 7 days, fined \$100. WHAT CONSTITUTES A JUNK VEHICLE?

The Ordinance defines a "Junk Motor Vehicle" as any motor vehicle that meets ALL of the following requirements

1. A vehicle that has been left on private property for more than seventy-two (72) hours or left on a public street, public way, or other property open to the public for purposes of vehicular travel or parking, or upon or within the right-of-way of any road or highway, for more than forty-eight (48) hours;
2. A vehicle that is three (3) year old, or older;
3. A vehicle that is extensively damaged, including but not limited to any combination of the following types of damage: deflated, wrecked, or missing tires or rims; missing or wrecked body parts; broken or missing headlights, taillights, or brake lights; broken, cracked or missing windows or windshields; missing all or part of the motor or transmission; missing or invalid license plate(s); or a vehicle that is otherwise apparently inoperable;
4. A vehicle that has a fair market value of \$1,500.00 or less.
