PRESIDENT'S MESSAGE

With our Thanksgiving Celebration, we have officially begun the Holiday Season. Winding down this year and looking forward with promise as to the bounty which the "New Year," holds.

This year, NANA's executive board has had additional meetings to establish some **long range plans**. These sessions were under the leadership of Barbara Henshaw and John Arthur. We all participated in personality typing, discussing what things could/would be solidifying for the neighborhood, in which direction for the neighborhood association to proceed and what contributes in making and sustaining the neighborhood. Personally, these planning sessions have been eye-opening. I learned what activities must take place, behind the scene, in order to make a desirable neighborhood. I therefore urge all of you: property owners, renters, employees in North Avondale to become involved in the neighborhood, to learn about it and to have your say. Together we can decide the most pressing issues facing our neighborhood, and pursue solutions.

In the training, we developed our **goals** for the neighborhood. These goals fall within three areas. NANA is already doing some things within each area but we want to do more. They are: **Schools**, we have two public schools and four private schools within the neighborhood and NANA needs to be more involved in shaping our youth. Currently, NANA has representatives on both the Burton & North Avondale Montessori Local School Decision Making Committees (LSDMC); **Safety**, we all want and are entitled to safe neighborhoods, there are many facets involved in having safe environments. Presently NANA's committees' are involved with Environmental, Landlord/Tenant and Block Watches; **Appearance**, considered in this area would be how the neighborhood looks, i.e., litter control, adopting community

CAR WASH TO REPLACE ANTONIO'S PIZZA

The Antonio Pizza Restaurant property at the northwest corner of Reading and Paddock Roads has been sold to Rick and Charles Pescovitz, former North Avondale residents. They plan to remove the present building and replace it with a self-serve car wash. This car wash will operate 24 hours a day and will not have an attendant on site. Since this property is currently in a Transitional Zone (T-Zone) & an Environmental Quality-Urban Design (EQ-UD), a development plan and public hearing is required.

The preliminary plan for this facility was presented to NANA at its November 11 meeting. If you want to know more about this development, please attend the December 9 NANA meeting when the developers will present their final plan and answer any questions residents may have.


NEIGHBORHOOD ZONING ALERT!


Within the next few weeks City Council plans to adopt a new Zoning Code for the city. In many ways this new code is an improvement over the present code because it is easier to read and to understand.

However, there are some changes that will adversely affect North Avondale, most important of which is the elimination of Transitional Zones (T-Zones). Without these T-Zones properties such as the **Gershuny lot** (Reading Road between Avondale Avenue and Barry Lane), the **Antonio Pizza property** (northwest corner Reading/Paddock Road), **West Mitchell** (abutting Kessler Avenue) and **part of S. Fred Shuttlesworth Circle** (abutting high density housing on Chalfonte Place) will be able to be developed without any input from the neighborhood, without any public hearing and without any agreed upon restrictions between the developer and the neighbors. For example, the McDonald's Fast Food restaurant proposed for the Gershuny property a few years ago year will be able to be built. T- Zone districts were originally written into the current zoning code to protect residential property owners from incompatible developments that may adversely affect them.

There are some who believe that because North Avondale has an Environmental Quality-Urban Design (EQ-UD) overlay zoning along the Reading Road corridor, the neighborhood will be protected against any undesirable development. This is not true. The EQ-UD deals only with the LOOK of the properties within its district, not with the USES that are permitted.

NANA representatives to the Cincinnati Neighborhood Zoning Task Force (CNZTF) have been trying to get the T-Zone district designation back in the proposed new code – unsuccessfully. If you find the elimination of T-Zone districts unacceptable, call or write City Council members and tell them so! Attend the December 9 meeting to help NANA decide what to do next.

 Yard waste and Xmas trees will be collected from 12/26 through 1/9 when set out on the regular waste collection day. No tree stands, ornaments or lights, please. After 1/9, citizens must schedule a pickup on their normal day by calling 591-6000.

NEW BLOCK WATCH CLUB FORMING

On Monday, November 24 at District 4 Police Station 48 neighbors from Abington, Ardmore, Dickson, Glencross, Lowry, Mitchell, Parker, Sturgis, Warwick and Wedgewood met to discuss problems in the area. Possible solutions were: more lighting - both city lights and home/porch lights; coordinate efforts with St. Bernard Police (an officer was present at this meeting) and District 5; increase Police presence; develop activities for youth; identify problem youth; talk to their parents; start a Block Watch Club; start a Citizens on Patrol; report both suspicious activity or crimes to Police; use a video camera to identify youth. **Don't leave valuables in your car - it attracts crime** For more information or to get involved call 221-6166 or send an email to: clmorse@fuse.net.

HISTORIES OF NORTH AVONDALE - PART 2 EXCERPTS FROM MARY KARTAL'S STORY

On the other side our neighbors were a gay couple. In 1960 this was not popular. They were forever on the defensive, soon the house was bought by the L family. Mr.L. was a mailman, Mrs. babysat. They had 7 kids and got an 8th one when his mother "forgot" to pick him up from the babysitter. The couple died within a week of each other. We were sad, they were such good people. I understand that the house was built for the president of HUC at the beginning of the century, and had a wonderful paneled library .

Mr. Charlie Taft, President Taft's youngest son rented the downstairs of the duplex next to them. For this reason, Burton Woods Lane got special treatment. The snow plough came through as it passed, first thing after a snow-fall, right in from Reading Road. This service stopped when Mr. Taft moved! Mr. Taft was a lovely, unpretentious man. He loved fishing. We knew Spring is here when the boat appeared on his small car, and that Fall is over when it was gone. He said he wanted his epitaph to read: "Gone fishin..." I don't know whether it does. At any rate, Mr. Taft had a hard time walking, moved out and the house was sold to the present owners.

There were many children on the street, black, white Catholic, Jewish, Protestant. They played together every day, had a wonderful time and were barely aware of the race riots, just a few blocks away. Not everything was idyllic all the time. There was a problem with the integration of the swimming pool. Another problem was the Church. The priest was obviously prejudiced against Jews and blacks. He did not object to some children playing in the churchyard, but chased the black kids off the premises and told the Catholic family not to let their children play with their Jewish neighbors. The Mitchell Mansion was a Catholic school that closed soon after we moved here. The church, the little white structure, still stayed a church for a while, but then the archdiocese wanted to sell it. There were many ideas floated about, a halfway house for young people out of jail, an AA rehab house, a house for unwed mothers, etc. Once when I casually remarked to a neighbor, that I don't really much care who does what as long as the place is well managed, the neighbor exploded:" It is easy for you, if you don't like it here, you can move, but we moved here to escape this stuff and we do not want it to follow us." I understood the point.

The New School seemed to be a good choice, but it got off to a rocky start. The campus was "open", which meant that the kids used me as a toy-lending-library. It changed after 2 girls were caught at the Greyhound terminal with \$20.00 trying to buy a bus ticket to Atlanta. Boundaries were set, rules established, and peace restored.

I do not know the history of many of the houses. I knew the owners, some very well, some superficially. I still refer to most houses by the old owners' names. I do miss the big elm trees that shaded the street and died from Dutch Elm disease soon after we moved in, but I am glad to see that the young trees are growing larger. The street is still as nice and friendly a place as it was so many years ago.

Catherine Stocks, (Wedgewood) died in her sleep at her home on Sunday morning November 9. She served on the NANA Board (1996-98) as the committee chair for Senior Citizens' Needs and one year was the Nominating Chair. Many of you will remember her from the NANA Meetings. She was the dignified woman, wearing a hat, asking deep philosophical questions and singing ever so beautifully at our Holiday parties. She will be missed.
