A Victorian bench painted by Cincinnati artist Brian Joiner has been donated to North Avondale Recreation Center in memory of Gwendolyn and Keith Hicks Rhodes. The Rhodes family purchased their home at 699 North Crescent Avenue (North Fred Shuttlesworth Circle) in 1961. Keith died in 1964 at age 33 and Gwendolyn remained in the home until her death January 1, 2004 at age 77. The bench includes two paintings by Brian Joiner. Joiner is a national award-winning artist with a permanent installation in the National Underground Railroad Freedom Center of sixteen black and white portraits of performers/activists. The theme of the bench is literature and nature and the paintings inspired by Rhodes family slides. Keith hailed from a family of educators including his parents Ella Hicks and Silas Rhodes and aunt, Ida Rhodes. Keith was a graduate of Morehouse University in Atlanta and received his MBA from Xavier University in 1954. Gwendolyn was an active member of North Avondale's PTA and NANA during the 1960's. She was a librarian at Guilford School and an avid gardener.

**AROUND CITY HALL**

**ZONE CHANGE ON S. FRED SHUTTLESWORTH CIRCLE/GREENWOOD.** On September 2, 2005 the Cincinnati Planning Commission unanimously approved a zone change on portions of S. Fred Shuttlesworth Circle and Greenwood Ave. from RMX (multi family residential) to SF-10 (single family, 10,000 sq. ft. minimum lot size). In recommending this change City Planner Larry Harris reported that "twenty-five (25) of the fifty one (51) properties in the RMX district have lot sizes of 10,000 square foot or larger. Most of the affected buildings were built as single-family residences and are currently used as single-family residences." An ordinance has been completed and been forwarded to the Neighborhood & Public Services Committee of City Council (chaired by Laketa Cole) for a public hearing. It is hoped that final approval by City Council will take place by the end of October.

**STYRENE LEAK IN EAST END RENEWS NANA REQUEST FOR REGULATION.** At a public hearing before the Community Development, Education & Intergovernmental Affairs Committee of City Council (chaired by David Crowley) on September 6, 2005, NANA renewed its request for City Council to pass legislation "to regulate hazardous chemicals transported or stored in the city." Speaking for NANA's Environmental Committee, Gerry Kraus stated that "it shouldn't have happened." If the City had heeded NANA's request in 1985 and again in 1989 when chemical discharges from nearby chemical companies affected North Avondale, the styrene leak in 2005 "would not have happened". A resolution to ask for federal, rather than local, oversight of hazardous materials in railroad tank cars was introduced by Councilmember Crowley and unanimously approved by City Council on September 8, 2005. In the meantime tank cars with hazardous chemicals, scattered throughout the city at chemical companies and/or rail spurs, will continue to be a threat to many neighborhoods.

**NANA SUPPORTS ENVIRONMENTAL JUSTICE ORDINANCE.** At a hearing before the Community Development, Education & Intergovernmental Affairs Committee on September 19, 2005 the NANA Environmental Committee lent its support to CUFA (Communities United for Action) in its quest to have City Council pass an Environmental Justice (EJ) Ordinance. An EJ Ordinance would provide "fair treatment and meaningful involvement of all people regardless of race, color, national origin, culture, education or income with respect to the development, implementation and enforcement of environmental laws, regulations and policies." Rather than passing a local EJ Ordinance, City Council opted to pass a resolution (September 21, 2005) urging the Federal Government, the Ohio General Assembly and the Ohio EPA to enact EJ legislation. *Note: An Ordinance is an enforceable law. A Resolution is a formal statement of opinion.*

**HISTORIC HANNAFORD HOME AT 3725 READING ROAD WAS SOLD AT AUCTION** on July 16, 2005. According to the Hamilton County Auditor's records the property was sold to Jerry Ernst of Hyde Park. Sale price was \$97,000.

**National Women of Colors Cancer Foundation** (NWCCF) is in desperate need of your assistance. Lowry Avenue neighbor **Deborah J. Green-Boone**, a breast cancer survivor, diagnosed in 2001 is CEO and founder of the Foundation. The NWCCF was founded April 2, 2002. Its vision was inspired by her personal experiences during treatment and recovery. Her survival and recovery, which she defines as returning to her role as a contributing member of her family and community, had just as much to do with her family and friends, as caregivers, "pampering her spirit," as it did with the physical and medical treatments she received. While the medical care was critical, without the positive mental and emotional health provided by family and friends, the results of the medical treatments would have been meaningless. Other breast cancer survivors and their caregivers support her belief that "pampering the spirit" benefits not only them, but, if concentrated geographically, could reap positive benefits to the broader community. One Foundation's programs is called, "Pampering the Spirit." It is one of the recovery programs along with: "Dealing with Hardships" and "Confronting Depression." A preventative program is, "Check Yourself," designed for young and old, women and men.

Other professionals needed are: attorney; doctors; survivors; caregivers; wellness professionals; licensed drug and alcohol substance abuse counselors; licensed social workers with child, family, and adolescent expertise; registered nurses with geriatric and psychiatric expertise; licensed psychiatrists; licensed psychologists; and pastoral counselors. **Jillian and Keira Hassel** (Rose Hill), members of the North Avondale Ropin' Rockets jump rope team, had a great competition at the Nationals Championships held at Disney World. Jillian won the Gold medal in the Single rope Freestyle Event and the Silver medal in One Minute speed. Jillian and Keira, as partners, won the Bronze Medal in the Pairs Freestyle Event. All the medals were won in the age 11 & under category

**Braxton Combs** (Eden Lane) with Stewart Issacs & Ben Ghosh took 1st, 2nd and 3rd place in the 11 and under boys freestyle event

**Marcus Taylor** (Edge Hill ) took 5th place in the prelims but came back to take 2nd place in the overall in the 18 and over freestyle event. He took 1st place in 1 minute single rope speed, 1st place in 3 minute single rope speed., 2nd place in 1 minute single rope speed and 3rd place in triple unders. With Alyssa Mendlein and Caitlin Stewart Isaacs he took 3rd place in the overall double dutch singles freestyle event. The three of them took 2nd place 2 years ago, 1st place last year and 3rd place this year - top three, 3 years in a row - outstanding. They will appear on **ESPN 2 on Monday, October 10th at 8:30 pm.**

**North Avondale Ropin Rockets** took 2nd place out of 65 teams in the freestyle events at the 2005 USA National Jump Rope Championships in Disney World, Florida in June. The jumpers had to qualify in the top 4 at the Regional event held in Indianapolis, Indiana in April. The team won 16 medals in all with only 17 jumpers. The Rockets will be performing at the Xavier mens' basketball game on Saturday, January 28th and at schools all over the city as a "Kick Off" for the American Heart Association's Jump Rope For Your Heart Program beginning in January. 
