<u>UPDATE ON:</u> VOLUNTEERS OF AMERICAN/OHIO RIVER VALLEY BUILDING A FIVE-UNIT INDEPENDENT LIVING FACILITY AT 3816 READING ROAD

Anthony Beasley, Vice-President of Program Development of Volunteers of America/Ohio River Valley (VOA/ORV) and his colleague attended the June 13th NANA General Meeting. Unfortunately, due the postal service being incredibly slow in delivering the newsletter attendance was smaller than expected.

Many questions and concerns were discussed to learn more information on the independent living facility to house individuals with Mental Retardation and Developmental Disabilities (MRDD). It is to be built on the empty lot on Reading Road between the former Bible College and the small park area at the corner of Clinton Springs. (the property starts where the former driveway next to the pathway is).

The purpose of the facility is to serve as an in-between 24 hour care/supervision and living independently without any supervision The V.O.A. does require a state license for this facility. There is a public Hearing for an Urban Design review before the Zoning Hearing Examiner on July 5, which NANA will attend. Regrettably the use of the facility will not be addressed at the hearing only the look. No one has expressed concern about the design which looks like a carriage house.

The two main concerns expressed were:

- 1. That the V.O.A. will not have staffing 24 hours a day. They would only provide 1, full-time position, 8 hours a day, 7 days a week. If the MRDD board feels it is necessary for 24 hour supervision for a particular client, it would be provided to a resident within that home.
- 2. That the V.O.A could not guarantee the residents would not have a criminal or sexual record. They did state that these records would have to be far in the past, not the primary diagnosis nor present any problems or danger to the other residents in the home.

A Motion was made and passed to table this until the next meeting and that actual written plans from the VOA and MRDD be provided to NANA.

CITIZENS ON PATROL By Marilyn Smith

I ironed my pants for the occasion – nice crisp line down the front. Stuffed in the extra large blue shirt, and proudly squished down the blue ball cap over my perfectly sprayed hair. I was COP girl and this was my first stab at fighting crime.

Of course everybody knows there's little or no crime in North Avondale – so I was all dressed up – ready to rock – and nobody to roll.

All that Police Academy training only to discover that COP (Citizens on Patrol) is a sluggish idea for North Avondale. Short of an outright yawn when I mentioned the program, some folks thought it was just plain silly – George wanted to give me a silver bullet – no gun, just the bullet

Frustrated, I called the Academy and explained my dilemma, (*COP girl with no escort*), and they took the situation seriously. Bond Hill to the rescue! They welcomed me – and my first patrol was memorable. I walked with a guy who's built like Mr. Clean and Robert, who has celebrity status in Bond Hill because everybody knows him. We took on California – step by step. We didn't solve any crimes, bust any drug lords, robbers, or vandals, but we did make a difference in our bright blue shirts with huge CITIZENS ON PATROL lettering.

We waltzed into deli's, bookstores, and bars, making notes about graffiti, broken windows, high grass, loitering youths, and smelly dumpsters. In the middle of the day with patrol cars within a 30-second radius we strolled ... and the residents adored us. They honked and waved, greeted us from balconies, stepped out of shops and expressed appreciation for Celebrity Robert, Mr. Clean, and COP girl.

Bond Hill today ... tomorrow North Avondale.

Due to the City of Cincinnati Ordinance No. 158-2006 Title XVI, "Neighborhood Quality of Life Unified Code" a broader enforcement of Quality of life issues will now be allowed. In the past, code enforcement was separated and enforced by specific people. For example: the Health Code, the Building Code, the Fire Code and public safety provision were each separately enforced by their own inspectors. If a building inspector happen to see a Health violation he could not inspect and issue a citation for the violation. Now, City agencies will be able to uniformly and consistently inspect and issue citations related to the overall conditions of a property, which may include violations for differing enforcement areas related to public safety or public health.

I learned about this new Ordinance at the District 4 Police Monthly Resource Meeting, (fourth Wednesday of each month at 6:30 p.m.- all are welcome). The Police have started their training.

Hopefully, this is a good thing. As long as the documentation of all citations is consistently computerized in one database for all the departments to see to avoid a duplication of efforts and stepping on toes, it will be a very good thing.

EDITORIAL

Dear Neighbors,

I am a Cincinnati native, and a life long member of North Avondale. When I returned to the City 11 years ago with my wife to raise our family we specifically selected North Avondale as a place to live. I have been proud to be part of the North Avondale tradition, that of diversity and unified community, until now.

The Smithermans have been a part of this neighborhood for 40 years, and collectively the family owns over \$2 million dollars worth of property in North Avondale. The only other family I know who can make this claim is the Harten family. We appreciate the variety of families that share the values of diversity, respect, and community.

Since late Fall 2005, the Southwick home on the corner of Marion and Dakota has had the word "nigger "* spray-painted on its east outside wall which is on the Dakota side near the rear of the house. Mr. Southwick's basic premise for leaving the vandalism there was that he did not put it there; that he is the victim and therefore shouldn't be responsible for its removal.

The Smithermans sent an ambassador to talk with the Southwicks about the vandalism. Others have talked with them as well. After time passed without "nigger" being removed, the circumstance was given media attention. Unfortunately, not only does the slur remain, but there was criticism for "putting our neighborhood business on TV." Once again, the term "trouble maker" is assigned to the one identifying the problem. I strongly recommend that everyone consider racist defacement very detrimental to all property values. This is a peak time for homes to sell in our neighborhood and you cannot expect anyone from New York, Chicago, Atlanta, or Washington D.C. to be willing to buy a home with "nigger" written on it or buy near such a home. Capitalism provides them the ability to live in Pleasant Ridge or Clifton.

Recently, emails have been sent back and forth to organize a block party. Only one neighbor brought up the "nigger" graffiti, particularly since Dakota was suggested as a possible block party location. My family often walks around the neighborhood. Since October, we have refrained from walking on Dakota because I will not allow my African-American sons to read the racism and interpret it as acceptable.

There are many neighbors who want the wall of the Southwick home cleaned purely because of their concern for humanity. Perhaps there are residents who do not have a moral problem with the word "nigger". (A neighbor indicated they were not even aware that "nigger" was written on a house.) However, I must reiterate what Pauline Daly has been telling us for years. When property damage is not repaired, it sends a message to wrongdoers that the area is a suitable place to engage in more destructive and/or criminal behavior. Beware residents, the delay in removing this vandalism which emphasizes racism has opened the door wide for displaying swastikas, anti-gay graffiti, and much more.

*Editors note: There are three places where there is graffiti. On the front gate pillar - "N O ! U"; on the back door and next to the door - "F U"; and "E U 4 ever"; on the Dakota side of the home – "(a symbol like a tongue sticking out) 4 restoration" and "FU Racist Nigger."

Also Mr. Southwick has been working with the City for months to get them to keep their promise to remove the graffiti.
