PRESIDENT'S MESSAGE

I was recently reminded how much my neighbors care about North Avondale. Not that I ever doubt the level of commitment to community we enjoy in our neighborhood, but I guess I don't always realize it. The city of Cincinnati recently released a draft of the proposed new zoning code, and it brought about lots of phone calls and emails from North Avondale residents.

You might not be aware of this, however, the city has spent the last several years developing a new zoning code that will guide development in Cincinnati for the next 30 years, and the proposed regulations were recently released. According to the city's website, "The Land Use Management group is responsible for the administration of the Zoning Code and other land use processes in the City Planning Department. This group's major work item for the year 2000 is the update of the Cincinnati Zoning Code. We are working to streamline the development process and ensure that the Zoning Code is supportive of the development and redevelopment activity in the city. The group is often responsible for balancing the needs of the development community with the residents in neighborhoods to ensure appropriate development."

This sounds like a worthy effort, however, the proposed zoning code has many of our neighbors upset and wondering why the city neglected an important part of the process – getting neighborhood input.

I'll be honest – I haven't read the entire proposed regulations yet, however, I am concerned for our neighborhood based on the proposed zoning changes on my street and others around me. The proposed zoning regulations would allow existing homes on my street and others to be torn down and replaced by 2 smaller lots with new homes. Why? There are large portions of our neighborhood that aren't in need of new homes; the existing historic homes are well maintained and there aren't vacant lots in need of development. How would this change benefit us as homeowners or North Avondale? The proposed zoning changes would also allow B&Bs on our street and others; that would lead to increased traffic, something none of us in North Avondale want on the street where we live.

Yes, I'm concentrating on the changes that directly impact me, however, any negative changes to one part of our neighborhood impacts all of us. Contact city hall and ask for the proposed zoning regulations – City Hall room 308, phone 352-3246. You can also find the proposed regulations at the city's website, www.cincinnatioh.gov/pages/-1444-/. Find out how your home is impacted. Attend a Planning Commission meeting (1st and 3rd Friday of each month, 9:00 am at Centennial Plaza Two, 805 Central Avenue, J. Martin Griesel Conference Room) and speak your mind. Call the NANA office and let us know your thoughts.

North Avondale is a thriving community, and while we certainly do have areas that could benefit from development and eased zoning requirements, the current proposed regulations go too far and will cause more harm than good. I can't help but think the city decided it knows what we want better than we do, and we can't let that slip by without speaking our mind. The good thing is, I don't worry about that – North Avondale has a well-deserved reputation for being a very vocal community, so do everything you can to get informed and

let the city know your thoughts.

PROPOSED ZONE CHANGE BAFFLE NEIGHBORHOOD By Gerry Kraus

Over 50 residents turned out at the April 8 NANA meeting to register their concerns about zone changes in North Avondale proposed by the City without any input from the neighborhood. Although a new citywide zoning code has been in the works for over two years, it was only in March 2003 that NANA received a map delineating proposed zone changes for North Avondale. Actually, NANA had been told that the goal of a new citywide zoning code was to make it easier to read and to understand, that the changes would be in wording of text and in nomenclature (e.g., an R-1A zone would become SF-20). At no time were NANA representatives who attended various public meetings during the past two years told that there would be zone changes that would affect land use in our neighborhood. Among the concerns expressed at the meeting were that several properties where the current zoning requires at minimum 20,000 sq. ft lot sizes for single family homes have been reduced to at a minimum 10,000 sq. ft. lot sizes and in some cases to 6,000 (minimum) sq. ft. lot sizes. This reduction in lot size designation would allow in-fill housing to be built on the larger lots. The new code would also permit business uses such as Bed & Breakfast Homes and Child Day Care homes in residentially zoned districts. Many residents believe that the success of North Avondale as a multi-ethnic, multi-racial, economically diverse neighborhood is the charm of its period homes situated on large lots. They cannot understand the rationale of tampering with neighborhood zoning when it is specifically strict enforcement of the present zoning that has made North Avondale the quality neighborhood it is. The present zoning is based upon the North Avondale Master Plan approved by the Cincinnati Planning Commission in 1974 and which is still very much a viable tool to maintain the integrity of our neighborhood.

Also of concern was the elimination of the Transitional (T) Zoning category. "T" zones had been established to reduce the negative impact of business uses adjacent to residential property or where low-density single-family housing abutted high-density multi-family housing. In all cases the proposed new zoning to replace the current T zoned areas in North Avondale permits less restrictive uses. The proposed new Commercial-Neighborhood-Mixed (CNM) for the business district in the vicinity of Reading Road, Avondale Ave. and Paddock Road (including the Gershuny property) would permit gas stations, bars with live music and other undesirable uses which are not permitted under the present zoning.

Two motions were passed at the NANA meeting: a motion to oppose all changes in the proposed new code for North Avondale that will make land use less restrictive than the present zoning; and a motion to create a zoning committee of interested people to meet with Peg Moertl, Director of the city's Community Development and Planning Department to relay to her the neighborhood's concerns about the proposed new zoning. The latter motion was made at the encouragement of Council Member David Pepper who had attended the NANA meeting and had listened to the concerns of residents.

ZONING COMMITTEE MEETS WITH CITY PLANNERS

On Sunday, April 13, about 25 people met at Barbara Henshaw's (2)

home (Rose Hill) to plan for a meeting with Peg Moertl. After input from the group Naomi Dallob (Barry Lane) was selected to be the spokesperson for NANA and to prepare a presentation. She was assisted by Rick Wayne (Beechwood Ave.), NANA Coordinator Charlene Morse (Burton Woods Lane) and Marvin & Gerry Kraus (Stratford Place). On April 21 the Committee met with Peg Moertl and City Planner David Efland at the home of Lois & Mel Nizny (Rose Hill). Naomi Dallob gave a short presentation highlighting concerns about 1) reduction of lot sizes that would permit in-fill housing and that would destroy the character of the neighborhood; 2) erroneous classification of properties; 3) the consequences of eliminating Transitional (T) Zoning; 4) business uses being permitted in residentially zoned areas; 5) the proposed zoning of the Avon Fields Golf Course on the east side of Paddock Road to SF-6 (6,000 minimum sq. ft. lot size). This would be totally incompatible with existing adjacent housing.

After the presentation Peg Moertl and David Efland were taken on a tour of the neighborhood where they could visually experience just how the proposed new zoning would adversely affect the character and ultimately the stability of our neighborhood. After the driving tour Ms. Moertl said she would review the concerns of the neighborhood and get back to the NANA Zoning Committee in 7-10 days. She did say that after hearing similar complaints from other neighborhoods the city planners decided to make all golf courses and parks SF-20 (single family housing on at a minimum 20,000 sq. ft. lots).

Shiloh Preparatory School Expansion Means Greater Education Choice
