AROUND CITY HALL ...AND THE COURT HOUSE

CURBSIDE RECYCLING TO CHANGE. Starting July 1 the city's curbside recycling** will change from every week to every other week. It has been documented that when a recycling program changes from weekly to less frequent pickups, participation drops by 30%. Too small green bins (the same size bins will have to do for 2 weeks rather than 1 week of recyclables) and losing track of which week to recycle have been cited as the main reasons for reduction in participation. Also expected is an increase in litter on the streets from bins placed at the curb on the wrong week & allowed to sit there.

Budget constraints have been cited as the reason for reduction in the collection of recyclables. However, a review of the figures indicates that the net saving will be minimal. Payment by the city to Rumpke to operate the curbside program will be reduced from \$2.1 million to \$1.7 million. The city will incur added costs because more waste, formerly recycled, will be going to the landfill. These costs include tipping fee (the present \$23.00 per ton is expected to increase by at least \$1.50 per ton) and the added fuel cost (think increased cost of gas!) as well as increased wear-and-tear on city garbage trucks, not to mention added payments to city workers. In addition the \$340,000 rebate that the city receives from the County Solid Waste District, based on the amount of tons recycled, will be reduced by at least 30%.

So the environmental benefits of recycling appear to be reduced at minimal monetary saving to the city – if not, indeed, at additional cost to the city! If you object to reduction of the weekly curbside pick-up of recyclables, call Council Members (City Hall telephone is 352-3000) or email your Council Members and tell them. *** The good news is that materials to be recycled (newspaper, corrugated, aluminum and tin cans, #1 and #2 plastics, and the recently added mixed paper) will continue to be collected.*

ZONE CHANGE APPROVED. On April 6, 2005 City Council unanimously approved a zone change at the northeast and northwest corners (the Gershuny and Antonio Pizza properties) of Reading/Paddock Roads. The zone change from CN-M (commercial neighborhood mixed business) to CN-P (Commercial Neighborhood-Pedestrian business) and RM-1.2 (residential multifamily) means primarily that no drive-thru businesses will be permitted in any future use at these properties. The RM-1.2 zoned district on the parcel of the pizza property abutting residences on Paddock Road is to give protection to those residential properties. The RM-1.2 zone replaces the protection provided by the transitional (R-1T) zone on that parcel under the old zoning code.

BURTON AVENUE BUSINESS STOPPED. The Mini Minute Market that has been selling food and merchandise out of a van on Burton Avenue has been ordered to cease

operation because it does not have a valid vendor's license. The City Treasurer's Office has no record of any license having been issued to the operator of this business. In the course of investigation of this business the question has arisen as to whether the City Zoning Code applies to city streets. The City Solicitor has stated that "the zoning code was not intended to regulate the public right-of-way." Based on the City Zoning Code that states "the Zoning Code applies to all land within the City of Cincinnati, including land owned by the City of Cincinnati and other local, state, or federal agencies", NANA is challenging the Solicitor's opinion. NANA has asked the Cincinnati Planning Commission and City Council's Law Committee (chaired by David Pepper) to review the Solicitor's interpretation. If the Solicitor's opinion prevails, vendors would be able to operate on the sidewalk and street of every residentially zoned district in the city!

CAR WASH & PAY DAY LOAN COURT CASES. The Common Pleas Court (Judge Dennis Helmick) has held that a car wash is not permitted at the Antonio Pizza property. This decision is being appealed by the Pescovitzes in the Court of Appeals.

In the Pay Day Loan Case the Common Pleas Court (Judge Fred Nelson) upheld the decision of the Zoning Board of Appeals (ZBA): that NANA and the individual plaintiffs filed their objection "out of time" (too late). The Judge also ruled that plaintiffs NANA, next door neighbor Julia and Audricia Brooks, and individual North Avondale residents (Bob & Mary Dee Novak, Bob & Janice Banks, Clayton & Betsy Gotwals) have no standing to go to court to question the decision of the ZBA; that only the property owner (the Pescovitzes) can object to the ZBA decision. NANA and the individuals involved are considering whether or not to appeal Judge Nelson's decision.

THE ARMORY PROJECT

Several years ago NANA and The Paddock Hills Assembly (NANA-PHA) formed a coordinating committee to consider the possible future uses National Guard Armory located across from the Avon Fields Golf Course. The committee's purpose was to prepare the neighborhoods to be proactive rather than reactive in the development of the property. Representatives of both communities comprised the committee. I acted as the committee's facilitator. After months of exploring alternative uses of the facilities, the committee concluded that the current buildings were attractive to any viable Arts, Educational or Commercial enterprises. The committee concluded the best use of the property would be housing desirable to the current Paddock Hills and North Avondale residents.

Committee member, Henry Brown, having vast experience in Residential development and construction quickly sketched a layout of duplex housing to demonstrate neighborhood competence to city administrators if and when the opportunity arose.

One committee meeting explored the viability of NANA-PHA developing the property. The committee discussed the advantages to the neighborhood developing the property. Some of the advantages, just to highlight a few are:

- Absolute control of the character of the property.
- No conflict between NANA-PHA.
- Any margin of profit would remain in the neighborhood for improving present and future problem properties
- Preservation of the hillside for future generations
- Demonstrating the competence of the governed to determine their future.

Also discussed was how NANA-PHA could become Developers. The first question addressed was determining the characteristics of a successful developer. Searching for models adaptable to meet the needs and concerns of NANA-PHA, we determined there must be a paid administrator, the ability to make decisions and a consistency of purpose. Additionally, we reviewed the behind-the-scenes problems with the Hunting Meadows Development in Bond Hill-Roselawn neighborhood.

One solution to locating a developer compatible with the desires of Paddock Hills and North Avondale is a Community Owned Urban Development not-for-Profit Trust. A Corporation created conforming to the 501 (c) tax codes and owned by NANA-PHA and thus directly owned by the residents of the neighborhoods. Locating a director with the necessary experience living in North Avondale or Paddock Hills would be straight forward. Likewise, locating experienced trustees would also be straight forward. NANA-PHA need only to ask residents through Community news papers and/or letters requesting applications. Trustees' personal time would be limited to locating and supervising the director. The missing link in the operational chain is the prompt creation of the documents needed for the creation of the Trust and the identifying of the trustees.

The coordinating committee's review of the Hunting Meadows development determined the two churches who

entered into partnership lacked experience and knowledge of the intricacies of real estate development and construction. The churches signed agreements giving all control away to a very knowledgeable developer. The resulting agreements are channeling hundreds of thousand of city dollars directly into the accounts of the developer, money lost forever to the residents of Bond Hill, Roselawn and Cincinnati.

In conclusion, North Avondale and Paddock Hills have all the components necessary to develop the property. Currently there are experienced real estate developers, Trustees, Directors and craftsmen working on these projects living in the neighborhood desiring to get their teeth into this project.

At the last meeting of the Coordinating committee I requested and was relieved of all further responsibilities to pursue the project and my presidency of the Business Association. I wish the neighborhoods well. I am always available to answer any questions or concerns you might have and am willing to volunteer my services as a consultant for the Armory Project.
